ORDER:

Therefore Sanctioned amount of Rs. 110000 (One Lakh Ten Thousand)/- towards revolving funds to eligible SHGs @ Rs,10,000 to each SHG under SM& ID Component of DAY-NULM.

The sanctioned funds shall be utilized as Revolving Fund to SHGs which builds institutional capacity of the SHGs in managing funds. The revolving fund would be part of the corpus along with SHGs own savings. The revolving fund can also be used for internal lending and the interest may be charged similar to the interest charged for lending from out of their own savings

The Finance Manager, MEPMA is requested to release an amount of Rs. 110000 (One Lakh Ten Thousand) /- from SM & ID Component of DAY-NULM scheme for the month of March 2019 through cheque issue in favour of the Chief Manager, ICICI Bank ,from 000801215695(Account (NULM Account)) to adjust the same to respective SHGs through DBT. The expenditure shall be met from SM& ID component of DAY-NULM

Therefore the Project Director Bhupalapally(Acharya Jayashankar) District is directed to verify the adjustment of SHG Revolving Fund now sanctioned to the groups as mentioned above and furnish acknowledgement and Utilization certificate for the amount now sanctioned and released. The status of release of funds should be updated in DAY-NULM website immediately. The funds to be utilized as per the guidelines of GoI and there shall not be any diversion in utilization of funds.
