

I Invite your kind attention to the Project Directors that with reference to the subject cited the Shelter For Urban Homeless component under DAY-NULM is directly monitoring by Supreme Court ,So as per the guidelines under this component sanctioned Shelters to be constructed as per the timeline , Time to time survey of urban Homeless , Mapping of shelters nearby colleges , Mapping of other than NULM shelters working on Urban homes , Providing entitlements of DAY NULM shelters as well as other than NULM shelters , Maintaining the registers , after five years O & M funds will not be released by DAY-NULM scheme it can be accommodated by the ULB finances .

In this regard it is noticed as per the Project Sanction Committee (PSC) for approval of Shelters, as on date out of 55 shelters 24 shelters are functioning, where 8 shelters are newly sanctioned in this financial year, and 23 shelters are not functioning till date in 12 Districts and in GHMC.
