Sub: PATTANA PRAGATHI – DAY-NULM- PM SVANidhi –Street Vendors Development –Pilot run for Digital on-boarding of Street Vendors and Training – Organizing Camps – Certain Instructions - Regarding.

The attention of the Commissioner, GHMC and MCs of GWMC, Nizamabad, Khammam, Ramagundum, Karimnagar, Adilabad, Palvancha, Zaheerabad, Armoor, Sangareddy, Miryalguda, Medak, Narayanpet, Peerzadiguda, Mahabubnagar, Sircilla, Nalgonda, Kamareddy, Jagityal, Bodhan, Jagityal, Manchiryal and Korutla ULBs is invited to the references cited, the Joint Secretary, MoHUA, GoI have informed that Digital onboarding of the Street Vendors and training, which is an integral component of PMSVANidhi Scheme. Accordingly, this office has issued instructions for conduct of Digital Onboarding camps from 25.09.2021 to 15.11.2021 with a caption "Pattana Pragathi – Main Bhi Digital" in 1st phase, followed by visits to markets to onboard left over vendors.

2. Further, as per the instruction of Secretary, MoHUA, GoI vide ref 6th cited, it is proposed to organize camps till 25.01.2022 for digitally onboarding of all remaining SVs since large number of SVs are yet to be onboarded. The following activities are to be taken up in the camps:

Role of ULB:

- Identify the location/s for conducting Camps daily.
- Plan suitable IEC and put banners and posters to create awareness amount SVs
- Mobilization of SVs 250 SVs per day in 2 shifts (@ 125 per shift)
- Logistics Arrangements: Chairs, Tables, Wifi Connection, Power Socket, Banners, Drinking water, Misc etc
- Educate the SVs for timely repayment of loans (EMIs) in order to be eligible for interest subsidy and for next higher tranche of loan
- Ensure COVID-19 guidelines are followed in the camps.

Role of Digital Payment Aggregators:

- On the spot generation of durable QR code (1 standy and 1 Sticker) and handed over to the SV in the camp only
- Linking of UPI to SVs saving bank account
- Training and handholding for Credit and Debit transactions
- Demonstrate Penny drop transactions of Rs.1/- from and into SVs saving bank account

- Support and follow up with SVs for atleast 30 day after onboarding to bring in behavioral change in SVs.
- Daily reporting of camp progress to ULB and State Office.
- 3. Further, vide ref 3rd cited, sanction was accorded for an amount of Rs. 1500/- (Rupees One Thousand Five Hundred Only) for each camp towards Logistic Arrangements [Chairs, Tables, Tent (if required), Drinking water, Stationary items, Misc, etc]. The same amount shall be sanctioned for these camps also but ensure attendance of atleast 100 SVs per shift.
- 4. Hence, the Commissioner, GHMC and MCs of 23 ULBs mentioned above are requested coordinate with DPAs and organize camps till 25.01.2022 and ensure mobilization of SVs as per the list available with DPAs, Digitally on-board and train all Street Vendors. The camp wise details shall be submitted to undersigned in the prescribed format (enclosed) for release of funds towards conduct of camps.

It is therefore requested to take necessary action in the matter.
