Attention to the sub. & refs. cited, the implementation period of PM SVANidhi scheme which was initially till March, 2022, has been extended to December 2024.

2. Further, the following change has been made in the Para 4 (Eligibility criteria of Beneficiaries) of PM SVANidhi Guidelines issued on 01.06.2020.

Existing Guidelines	Revised Guidelines
The Scheme is available to all street vendors engaged in vending in urban areas as on or before March 24, 2020.	<b>The Scheme is now available to all street vendors engaged in vending in urban areas.</b>

3. The revised guidelines are effective from 27.07.2022.

4. Hence, the Commissioner, GHMC, CEO, Secbad Cantonment Board and MCs of all ULBs are requested to follow the revised guidelines in implementation of Pattana Pragathi Street Vendors Development – PM SVANidhi Scheme.


