- Updation of Mahila Aroghya Samithis (MAS) under National Urban Health Mission (NUHM) targets are communicated in the extension of MOU from National Health Mission ,Telangana . Accordingly update the MAS Group formation in the MEPMA webportal .Format -1
- In this regard with reference to the 1<sup>st</sup> cited, it is directed to make functioning of MAS group with involvement of ASHA, where ASHA is a member secretary for MAS Group.
- Update the MAS book keeping upto date covering all indicators of IMR MMR, Morbidity, Health savings, Health, Water and Sanitation talks and related to MAS meetings.
- Mapping of MAS to concern Urban Primary Health Centers (UPHCs) and display of the MAS meeting Dates at UPHC
- Orientation to all ASHAs on convergence activities of Community Based MAS activities and information related on incentives Rs 300/ to ASHA for attending monthly MAS Meetings.
- Proposal to be submitted on the MAS untied Fund every year @ Rs 5000/- with MAS resolution.
- Certification by DMCs of MEPMA on functioning status of MAS meeting regularly with ASHA in the prescribed format –II
