ORDER:

Vide reference 1st cited, the GOI has given guidelines under NULM to establish City Livelihoods Centers (CLCs) in all ULBs of NULM towns. The concept of CLCs is to bridge the gap between demand and supply of the goods and services to the urban poor.

In this regard, Each CLC will be provided a non recurring grant of Rs. 10 Lakhs as untied funds and the amount will be released in 3 installments. The milestones for release of installments may be as follows

- 1st installment 30% released by SULM to ULB within one week of the proposal, sanction order is approved
- 2nd Installment 40% after the staff of CLC is recruited
- 3rd Installment 30% will be released offer launch of CLCs.

In the reference 2nd and 3rd cited above, the Mission Director, MEPMA has issued orders for utilizing an amount of Rs. 9.00 Lakhs from the available funds for establishment of CLCs in Nalgonda, Suryapet & Miryalguda NULM Towns @ 3 CLCs each Rs.3.00 Lakhs and the amount of Rs. 6.00 Lakhs to Nizamabad NULM Towns @ 2 CLCs each Rs.3.00 Lakhs as 1st installment.

In reference 7th cited, the Project Director, Nalgonda district is requested to release an amount of Rs. 9.00 Lakhs for establishment of 3 CLCs as there is no available budget under SM & ID component of NULM funds for utilize the amount for establishment of CLCs.

In reference 6th cited, the Project Director, Nizamabad district is requested to release an amount of Rs. 6.00 Lakhs for establishment of 2 CLCs as there is no available budget under SM & ID component of NULM funds for utilize the amount for establishment of CLCs.

Vide reference 4th & 5th cited, the proposals received from Adilabad, Khammam and Warangal districts for NULM towns have been recruited the staff of CLC after releasing 1st installment of 30% and recommended for the release of 2nd Installment of 40% i.e an amount of Rs. 4,00,000/- to each City Livelihoods Centers (CLCs) in Adilabad & Khammam ULBs of NULM towns.
