As per the operational guidelines of SM & ID it is proposed to conduct the trainings only in NULM towns. The other towns which are under Non-NULM and the budget not received till now in Non-NULM towns are instructed to discontinue the CLRPs till order issued from the Head Office of MEPMA.

The Project Director, Nalgonda district informed vide reference 3rd cited that he has not received any trainings budget from April 2014. It was so it is decided to release training funds from June 2014 to March, 2015 as 1st Phase because of reorganization the staff budget released from June, 2014 instead of April 2014 and from April 2015 to March, 2016 as 2nd phase.
