

In the reference 3rd to 6th cited above, the Project Director, Karimnagar, Nizamabad Medak & Adilabad districts submitted the proposals for release of support funds towards Social Mobilisation activities in NULM towns and Non NULM towns.

In the reference 2nd cited, It is resolved in the 12th EC at agenda No.9 to provide support fund to TLFs / SLFs for strengthening of the SHGs of PWDs at ULB level through PWD Volunteers / Cluster Level Resource Persons (Disability) to facilitate the PWD groups in all aspects of services monitoring the functioning of SHGs of PWDs. Therefore the PWD Volunteer are also called as the Cluster Level Resource Persons (Disability).

In the reference 1st cited above, as per the guidelines of NULM it is decided to conduct the trainings only in NULM towns. The other towns which are under Non-NULM and the budget not received till now in Non-NULM towns are instructed to discontinue the PWD Volunteers till further order is issued from the Head Office of MEPMA.

In this regard, the funds towards training under sub component of SM & ID is proposed to release only for NULM towns in Karimnagar, Ramagundam & Jagtial ULBs Nizamabad ULB Sangareddy & Siddipet and Adilabad ULB
