complete the following tasks under SM&ID component in newly formed ULBs / in the Grampanchayaths merged to existing ULBs in their respective jurisdiction:

- Convergence meeting at District Level with DPM, APM, SERP. Sthreenidhi Staff, VOAs and MEPMA Staff regarding handing over of data all VOs and SHGs'
- Orientation to VOAs on all MEPMA activities.
- Amendment of Bylaws of VOs as ALFs
- · Formation of Town level Federations (TLFs) in newly formed ULBs.
- · Mapping of ALFs in GPs merged in existing ULBs to existing TLF.
- · Formation of new SHGs of women, vulnerable persons (Sanitation workers, Rag Pickers, Transgender, etc)
- · Ensure regular meetings of ALFs.

Further, all the designated Special Officers, MEPMA are also directed to monitor the status of above activities in respective ULBs / Districts during their visits.
