I invite kind attention of the Commissioner, GHMC and District Collectors in the Telangana State to the references cited, in the reference 2<sup>nd</sup> cited in the Government have informed that the Advocate General, High Court of Telangana has informed the Government that the Hon'ble High Court while hearing the W.P. PIL No. 76 & 77 of 2020 desired certain information with regard to involvement of NGOs in relation to the facilities provided to such persons who are housed in the shelter homes.
