Linvite the attention of the Project Directors, MEPMA concerned to the reference cited wherein instructions were issued to all the Project Directors, in preparation of Action Plan -2014-2015 regarding submission of proposals for releasing of Revolving Fund (RF) Capacity Enhancement Fund to SLFs and Town Vikalangula Samakaya (TVSs).

As per the NULM Guidelines it is proposed for release of RF to SLFs & TVS (Disability Federations) of NULM towns is Rs 50,000/- as per the following eligible criteria.

- TVS shall be within the slum
- M6 must have been registered.
- Minimum seniority of 6 months from the date of formation of TVS
- TVS must Conduct Regular meetings
- TVS must have opened its A/c in the Bank.
- Consistency in minimum monthly savings @ Rs 50-100/- per month per SHG from the date of formation of TVS
- must have trained TVS Resource person
- must maintain TVS books of Accounts properly.
- must have membership of at least 15 SHGs
- TVS must have minimum corpus fund of Rs 15,000/-
- Audit of TVS should completed

In this regard, the Project Directors, MEPMA are requested to submit the proposals of Revolving FUND of eligible TVS along with Bank Statements & other required documents (Encl) of NULM towns to this Office by Sept 29th Sep 2014.
