Sub: Development of eFMS module for SHG Revolving Fund under DAY-NULM-Hosting of application in website for the approved 59 ULBs – Regarding.

With reference to the subject cited above, it is to inform that eFMS module for SHG Revolving Fund has been developed. The Eligibility Criteria for SHG to get Revolving Fund @ Rs.10,000/- is as follows:

- 1. SHG shall be eligible for Revolving Fund after 3 months from the date of formation.
- Member data i.e., 10 members for Women and 5 members for PWD SHG shall be updated.
- 3. All the members Aadhaar seeding shall be completed.
- 4. SHG shall not receive Revolving Fund earlier.

The 59 ULBs who are Non-NULM during 2014-15 and 2015-16 have been enabled for SHG Revolving Fund. The following are the steps for approval of SHG Revolving Fund in Town Mission Coordinator login.

Town Mission Coordinator Login:

- Open EFMS website (http://www.efms.serp.telangana.gov.in/MEPMAEFMSTG). Login with the same credentials i.e., PRP_xxx(ULB code) and password.
- Go to Passbook Upload -> Select SHG RF and upload SHG SB account passbook.
- 3. The SHGs for which passbooks uploaded will be visible in Approval screen. Select the SHGs by clicking on the select box and forward to PD.

Project Director Login:

- Open eFMS portal and login with the credentials (same as VLR/IS i.e., PD xxxx FIN).
- 2. The SHGs forwarded by TMC will be displayed in RF approval screen along with passbook.
- 3. After thorough verification, Project Director can forward the SHGs to MEPMA, head office for releasing of revolving fund to SHG SB account through Direct Beneficiary Transfer.

Further, the 15 NULM ULBs during 2014-15 and 2015-16 are instructed to update already released Revolving Fund to SHGs in their logins in MEPMA portal. Then only the ULB logins will be enabled, otherwise there may be a chance of double payment of Revolving Fund (RF) to the SHG.

Hence, the Municipal Commissioner/Project Directors are instructed to submit the proposals immediately for releasing of SHG Revolving Fund.
