Sub:- MEPMA-NUHM –community Process -GHMC-UCD- Formation of two to three Mahila Aroghya Samitis ( MAS) –in all SLFs -– MAS-- formation - ASHA mapping - certain instructions –Reg

Ref: - 1. National Urban Health Mission ( NUHM) PIP Telangana .

2. Minutes of Governing Body Committee, CUHS, NUHM, and GHMC held on 17.03.2016 at GHMC office.

3. MOU between MEPMA and Chairman, City Urban Health Society (CUHS) GHMC Dated on 18.08.2016.

- The National Urban Health Mission (NUHM) aims to address the health concerns of the urban poor through facilitating equitable access to available health facilities by rationalizing and strengthening of the existing capacity of health delivery for improving the health status of the urban poor. Similarly the communitisation process will draw heavily on the existing community organizations and Self Help Groups developed under SJSRY other initiatives.
- NUHM Coverage: with more than 50000 population are covered under NUHM.
- With reference to 1<sup>st</sup> cited in ,MD MEPMA nominated as a member of Governing Body committee, of City Urban Health Society NUHM- (GHMC), SMC of MEPMA nominated as a member of Executive body of City Urban Health Society.
- With reference 2<sup>nd</sup> cited above as per the, MOU between MEPMA and Chairman, City Urban Health Society (CUHS) GHMC (Commissioner, GHMC) Dated on 18.08.2016, it is agreed to implement the community Process i.e formation of MAS and strengthening of MAS in NUHM (National Urban Health Mission) in GHMC through MEPMA as a development partner for implementation of community process of NUHM with coordination of UCD department of GHMC.
- Community Participation: The effective participation of the community in Planning and management of health care services it would promote a Community Health Volunteer Urban Social Health Activist (ASHA) for covering 200 to 500

households) and creation of Mahila Arogya Samiti (50-100 Households). The NUHM provide annual grant of Rs 5000 to the MAS every year. And in training component Rs 10,000 allocated for trainings.

- In existing GHMC-UCD in existing community based institutions- Slum Level Federations (SLFs) covering average 250 to 300 Households at slum level. In this context as per the available SHG members in SLFs it is proposed to constitute the two to three MAS with 10-15 EC & OB members in all SLFs of GHMC i.e. by covering 100 SHG members to form the one MAS.
- Bank account to MAS: Separate Bank Account has to be opened separately for each MAS with joint account shall be in the name President of concern SLFs and Accredited social health activists (ASHA)/ Health Community Resource Person (HCRP) who is the member secretary of MAS.
- On line updation: MAS details has to be updated in MEPMA web portal.
- Health -ToT: For MAS member training it is decided to identify the 20 -30 Health CRP ToT for each circle further to train the MAS members to concern SLFs. And submit the report on Health CRP Tot to Head Office by August 27<sup>th</sup> 2016 (Criteria for selection of Health -CRP is enclosed).
- Accredited social health activists (ASHA) mapping in existing SLFs: as per the NUHM guidelines Urban accredited Social Health Activist (ASHA) has to be identified for covering 200 to 500 households. In this connection it is proposed to map the existing ASHAs in all SLFs.

Hence it is requested to follow the above guidelines and submit the report on MAS formation, ASHA Mapping, Health CRP Tot for implementation of Community process of NUHM in GHMC through UCD wing of GHMC as per the time line.

## **ANNEXURE-1**

## I. Criteria for selection of Health Community Resource person (CRPs):

Health CRP shall fulfill the following criteria

- CRP shall be the SHG members with more than 3 years seniority
- Minimum qualification Intermediate/Degree
- Willingness to move around the allotted House Holds
- Age not more than 40 years
- Shall be married & permanent resident of the ULB
- Preference shall be given to disadvantaged sections ( single women, SC,ST,Minority, widow)
- After selection she is supposed to attend the ToT training for four days (Residential training).

## II. Job chart of Health Community Resource person (CRPs) TOT:

- Each Health CRP will be allocated the nearby SLFs 10-15 as per the selection criteria.
- Health CRP TOT supposed to attend the SLF meeting regularly and monitor the following items (for each SLF meeting (MAS meeting training resource fees) resource fees Rs 175/- will be provided.
- > Formation of MAS: During SLF meeting give orientation to all SLF members on importance of MAS
- > SLF EC & OB members shall select 10-15 members of MAS covering 2-3 MAS for SLF
- ➤ Bank account to be opened in the name of SLF name by adding MAS-I,MAS-II,& MAS-III
- ➤ Distribution of training module and Registers (Book –keeping 14 Registers) has to be discussed and to make book keeping system regularly at SLF level.
- Phase manner MAS training has to conduct to all members on National Urban Health Mission (NUHM).
- Work done report has to submit to the concern Community Organizers (Cos) and Town Level Federations (TLFs).
