ORDER:

In the reference 1st cited detailed guidelines were communicated from GOI regarding sanction of Revolving fund to SHGs and their federations. As per the guidelines, GOI provided one time revolving fund support of Rs. 10000/- to each SHG, which have not availed such support earlier., which would form part of the corpus along with their own savings and also be utilized towards internal lending among its members with interest leveled based on the decision of SHG.

In this connection it is decided to release the revolving Fund (RF to newly formed SHGs for the Year 2015-16 by following the eligibility criteria and process (enclosed in Annexure-II) to avail RF to SHGs and also where targets of SHG formation are achieved more than 100% in the year 2014-15.

In the reference 5th and 6th cited above the Project Directors, MEPMA, Warangal, Khammam districts submitted the proposals of Revolving Fund (RF) to 107 excess SHGs in the year 2014-15 and the newly formed 255 SHGs in 2015- 16 .

The details are worked out for the SHGs as per the proposals and online SHGs updation

Accordingly, the Project Directors of above districts are directed to release the funds for Revolving Fund to SHGs for newly formed groups in the year 2015-16 and also where targets of SHG formation are achieved more than 100% in the year 2014-15 duly following eligibility criteria, process and as per the online updation of the groups.(enclosed –Annexure - III)

The Project Directors shall furnish the details of sanctions to Mission Director, MEPMA & also update it online. It may be noted that if any discrepancy is noticed it will be treated seriously.

Therefore sanction is hereby accorded for the payment of Rs. 10,20,000/- (Rupees. Ten Lakhs Twenty Thousand only) in favour of Project Director, Khammam district Rs. 20,80,000 (Rupees. Twenty Lakhs Eighty Thousand only) in favour of Project Director Warangal district towards release of Revolving Fund to 783 SHGs which are excess SHGs formed in 2014-15 and newly formed SHGs in 2015-16 to the concern Project Directors, MEPMA, DPMU as the mentioned in the tables above.

Hence, the Finance Manager, MEPMA is requested to release an amount of Rs. 10,20,000/- (Rupees. Ten Lakhs Twenty Thousand only) in favour of Project Director, Khammam district Rs. 20,80,000 (Rupees. Twenty ~~Six~~ **Lakhs** only) in favour of Project Director Warangal district towards release of Revolving Fund to SHGs to the concern Project Directors, MEPMA, DPMU as per the above statements.
