

**Minutes of the review meeting held on 15-06-2015
by the Mission Director, MEPMA at mini conference hall, C&DMA**

The Mission Director, MEPMA has reviewed the Action Taken Report on the decisions taken on the Staff review meeting held on 08-06-2015 with the MEPMA staff and representatives of CGG and given following directions.

Pradhan Mantri Suraksha Bima Yojana (PMSBY) and Pradhan Mantri Jeevan Jyothi Bhima Yojana (PMJJBY):

- The simplified format already has been given to CGG to develop screen to enter particulars of SHG members and sanitary workers of all ULBs. Hence, CGG is directed to complete the screen within three days.
- To inform all Project Directors and Commissioners to organize meetings with Bank Managers and take necessary steps to complete enrollment of PH workers by ~~tomorrow i.e., on 16-06-2015~~ 16-06-2015.
- Allot 4 to 5 Municipalities to each staff member of Head Office for effective monitoring of enrollment of all members of SHGs and PH workers on daily basis.

Social Mobilization & Institution Development:

- To identify and list out all the Health CRPs of all ULBs within one week.
- To prepare innovative Project on Social Action Committee for onward submission to Govt of India.
- To submit a proposal to train distressed women by CRPs to resolve neighborhood level issues by utilizing the TLF corpus and also serves of SRACO.
- To speed up the preparation of data entry screens and reporting formats on revolving fund.
- To design module for National Urban Livelihood Mission and NUHM within one week by CGG in consultation with NUHM.

- To organize surgical camps and aids and appliances distribution camp, one camp in each district on monthly basis for rehabilitation of Persons with Disabilities.
- Video Conference scheduled on 19-06-2015 with TLF, SLF, COs and Bankers with all ULBs of Telangana on insurance schemes, Swatchh Bharat etc.
- The study and report pertaining to RSBY is not yet submitted. Hence directed once again to submit report covering details such differences and advantages of Rastriya Swasth Bhima Yojana (RSBY) to implement by MEPMA.
- Capacity Building training program to 102 COs of GHMC at MCRHRD is scheduled in next month.
- Web portal is not yet developed for accessing the performance of Project Directors. Hence it is directed to complete before next review.
- No proposals are received so far. Hence please it is directed to obtain innovative proposals from all ULBs.
- To address MD Sthreenidhi to provide the SHGs list which are not tallying and which are not able to locate in particular SLF so as to resolve the problem of adjustment of Rs.78Lakhs in appropriate account of SHGs.

- To obtain attendance of trainees should be Aadhar based.
- Video conference with Skill training providers is scheduled on 20-06-2015.
- To address letter to Municipal Commissioners to conduct periodical inspections of trainings.

Shelter for Urban Homeless:

- Letter to be addressed to the Municipal Commissioners instructing inspect and to submit a report on progress regarding construction / refurbishment and also the Operation and Maintenance (O&M) details of running Shelters.
- The SMC, LH should inspect the running shelters and submit the comprehensive report.

Vaddi leeni Runalu:

- Municipal Commissioners shall be informed about the release of VLRs.
- VLR information shall be kept on CDMA website and also establish link between MEPMA and CDMA websites.

Utilization of Serves of Data Entry Operators: in Nagarapanchayats

- Payment of Data entry charges shall be made to the DEOs through TLF/ SLF based on Job work done. The Municipal Commissioner can meet the said expenditure from general funds. A letter may be addressed to the Commissioners in regard.
