The progress of all activities of MEPMA has been reviewed vide the ref. cited and the following instructions have been issued to strengthen the existing network of community structures like SHGs/SLFs & TLFs, to develop SHG members into entrepreneurs towards sustainable improvement of livelihoods:

- Project Directors should ensure to avail loans under Bank Linkage by all the eligible SHGs (6 months completed SHGs). There should not be any SHG left not availing loan single time.
- To enhance the Bank Linkage loans additionally 50% against the financial target given for the year 2022-23.
- Project Directors to instruct the ULBs to follow the Micro Credit Plan (MCP) and utilize the amount for taking up Income Generating Activities (IGAs) towards sustainable livelihoods. (Activities should be updated in Asset creation screen regularly)
- Project Directors to identify the interested members through SLFs & TLFs & explore new ideas to develop interest among SHG members into Entrepreneurs keeping in view of the local demand.
- Improve the credit worthiness of women led enterprises in order to improve their access and eligibility for credit funding.
- To identify the SHG products @5 per ULB and facilitate them in branding and packaging and to encourage digital marketing.
- To maintain SLF wise registers and update the member wise enterprise details on daily basis in Enterprises Mobile App developed by TCS. (will be launched by next week)
