The Principal Secretary (MA), MA & UD Department has directed to conduct survey and registration of street vendors in all ULBs by appending the survey format and format of identity card vide ref 1st cited along with further steps to be taken in all ULBs. Few RDMA's could complete the workshops and the followings regions are due for conducting the workshops.

All ULBs have to form Town Vending Committees and conduct meeting once in every month compulsorily. Now the first meeting of TVC shall be convened and to decide fee for registration of each street vendor for issuing identity card and Vending License as per the Act ref 3rd cited. The Regional Directors are requested to monitor this programme personally.

Further, it is decided to conduct orientation workshops region wise with all Project Directors of MEPMA, Municipal Commissioners, DMC (LH) and TrPO/ PRPs across the state during last week of May 2014. The Project Directors of MEPMA mentioned will be responsible for conducting the programme and expenditure shall be met from IEC fund of UCDN, as per norms. This programme is essential to understand the Central Act, guidelines issued by the Gol and the State Policy on street vendors. The following will be the schedule of workshops.
